String READ\_PHONE\_STATE

Allows read only access to phone state, including the phone number of the device, current cellular network information, the status of any ongoing calls, and a list of any PhoneAccounts registered on the device.

## permission.ACCESS\_FINE\_LOCATION

String ACCESS\_FINE\_LOCATION

Use for accessing location for user. Allows an app to access precise location. Alternatively, you might want ACCESS\_COARSE\_LOCATION.

## permission.WRITE\_EXTERNAL\_STORAGE

Allows an application to read from external storage.

This app declares the WRITE\_EXTERNAL\_STORAGE permission, as this app API level is 19 it is implicitly granted this permission.

### permission.CAMERA

Required to be able to access the camera device.

This will automatically enforce the manifest element for all camera features.

### permission.GET\_ACCOUNTS

String GET\_ACCOUNTS

Allows access to the list of accounts in the Accounts Service.
