Notes to the un-audited consolidated financial results for the quarter and nine months ended December 31, 2022:

- 1 The above un-audited consolidated financial results for the quarter and nine months ended December 31, 2022 have been reviewed by the £udit Committee and approved by the Board of Directors at their respective meetings held on February 3, 2023. The statutory auditors of the Company have reviewed the above consolidated financial results for the quarter and nine months ended December 31, 2022.
- 2 These results have been prepared on the basis of un-audited consolidated financial statements, which are prepared in accordance with the Indian Accounting Standards (Ind-AS) as prescribed under Section 133 of the Companies Act, 2013 and notified by the Ministry of Corporate Affairs under the Companies (Indian Accounting Standards) Rules, 2015 (as amended).
- 3 The un-audited consolidated financial results include the financial results of the Company and its four wholly owned subsidiaries Vakrangee Finserve Limited, VL E-governance & IT Solutions Limited, Vakrangee Digital Ventures Limited and Vakrangee e-Solutions Inc. (together referred to as 'Group').
- 4 During the quarter ended December 31, 2022, the Company has granted 49,600 new options under Company's "ESOP Scheme 2014" to its eligible employees.
- 5 The Company's activities predominantly comprise providing various services through Vakrangee Kendra. Considering the nature of the Company's business and operations, there is only one reportable operating segment i.e. Vakrangee Kendra.
- The Board of Directors at their meeting held on October 10, 2021. considered and approved to restructure the business by way of a Scheme of Arrangement for Demerger ("Scheme") whereby the E-Governance & IT/ITES Business (Demerged Undertaking) of Vakrangee Limited ("Demerged Company") will be demerged into the VL E-Governance & IT Solutions Limited (formerly known as Vakrangee Logistics Prvate Limited) ("Resulting Company") as a going concern basis. Pursuant to the Regulation 37 of the LODR the Company has obtained No Objection Letter from the BSE and NSE vide their letter dated 11th March, 2022 and subsequently, an application was made to the National Company Law Tribunal (NCLT) for further directions.

The Hon'ble NCLT, by way of its order dated January 20, 2023 has inter alia directed the Company to convene a meeting of its equity shareholders on March 3, 2023 at 11.00 a.m & unsecured creditors on March 3, 2023 at 02.00 p.m., to approve the arrangement embodied in the Scheme.

- 7 The figures of the previous year / period have been regrouped / rearranged / recast to render the comparable with the figures of the current period.

Independent Auditor's Review Report on Unaudited Consolidated Financial Results of Vakrangee Limited for the Quarter and Nine Months Ended December 31, 2022 pursuant to the Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended

TO THE BOARD OF DIRECTORS OF **VAKRANGEE LIMITED**

- We have reviewed the accompanying Statement of Unaudited Consolidated Financial Results of Vakrangee Limited ("the Parent") and its subsidiaries (the Parent and its subsidiaries together referred to as "the Group"), for the guarter and nine months ended December 31, 2022 ("the Statement"), being submitted by the Parent pursuant to the requirement of Regulation 35 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, ("the Regulation").
- This Statement, which is the responsibility of the Parent's Management and approved by the Parent's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder ("Ind-AS") and other accounting principles generally accepted in India. Our responsibility is to express a conclusion on the Statement based on our review.
- We conducted our review of the Statement in accordance with the Standard on Review Engagement (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of 'ndia. A review of interim financial information consists of making inquiries, primarily of the Parent Company's personnel responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing specified under Section 143(10) of the Companies Act, 2013 and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

We also performed procedures in accordance with the Circular issued by the SEEI under Regulation 33 (8) of the Regulations to the extent applicable.

- The Statement includes the results of the following wholly owned subsidiaries.
 - Vakrangee Finserve Limited
 - VL E-Governance & IT Solutions Limited (formerly known as Vakrangee Logistics Private Limited)
 - Vakrangee Digital Ventures Limited
 - Vakrangee E-Solutions Inc. (Philippines)
- Based on our review conducted and procedures performed as stated in paragraph 3 above, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Indian Accounting Standard and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, including the manner in which it is to be disclosed, or that it contains any material misstafement.

We did not review the interim financial results and financial information of one subsidiary included in the consolidated unaudited financial results, whose interim financial results I financial information reflects total revenues of ₹ 861.64 lakhs and ₹ 2,860.61 lakhs, total net profit/(loss) after tax of ₹ (20.13) lakhs and ₹ (12.49) lakhs and total comprehensive income of ₹ (20.13) lakhs and ₹ (12.49) lakhs, for the quarter ended December 31, 2022 and for the period from April 1,

Our conclusion on the Statement is not modified in respect of the above matters.

- (a) The consolidated financial results of the Group for the year ended March 31, 2022 were audited by another firm of Chartered Accountants, who issued an unmodified opinion vide their report dated May 13, 2022.
 - (b) The consolidated financial results of the Group for the quarter and nine months ended December 31, 2021 were reviewed by another firm of Chartered Accountants who vide their reports dated January 22, 2022, expressed an unmodified conclusion on those financial results.

Our conclusion is not qualified in respect of those matters.
